- Any business relationships among individuals treating the patient, or between the organization and any other health facility.

## Missed Appointment Policy Statement

- PureView Health Center has adopted a No-Show (missed appointment) policy in March of 2016. This means any appointment that a patient does not attend and did not call the office to cancel or reschedule within an appropriate amount of time has no-showed an appointment,
